Golf:

Golf membership includes full access to the golf course, clubhouse, year-round social events, tennis courts, pools, and driving range at no additional cost every day of the week. Golf members can also enjoy Acumen Golf's 2 additional golf courses, Brandermill Country Club and Birkdale Golf Club, located in Chesterfield County, for just a cart fee unless you are on the cart plan, then there is no additional cost. Birkdale and Brandermill access is restricted to after 11AM and reservations can be made through the HGC Pro Shop with a 5 day booking window. That's 54 holes of great golf for you to enjoy!

Under 35 Golf Membership

Individual - \$150 for golf only, \$245 with unlimited cart use per month

Family - \$200 for golf only, \$330 with unlimited cart use per month

Full Golf Membership

Individual - \$175 for golf only, \$270 with unlimited cart use per month

Family - \$225 for golf only, \$355 with unlimited cart use per month

Off-Peak Golf Membership

Individual - \$150 for golf only, \$245 with unlimited cart use per month

Family - \$200 for golf only, \$330 with unlimited cart use per month

*Golf is restricted to after 10am on Weekdays and after 12pm on Weekends and Holidays. This category does not include reciprocal access to Birkdale and Brandermill.

Unlimited Use Cart Plan

Cart plan usage is valid at all 3 Acumen Golf Properties, Brandermill Country Club, Birkdale Golf Club and Hanover Golf Club.

\$95 a month for Individual usage, \$130 a month for Family, *12-month commitment required

*Group Incentive

If a group of 3 or more golf members all join at the same time, they will be eligible for a \$50 unlimited cart plan rate for the first 12 months of membership.

Golf members have a monthly Food and Beverage minimum of \$35 which can be spent during visits to the club to play golf or when using the club for non-golf events or attending social events.

Social members have a monthly Food and Beverage minimum of \$25 which can be spent during any visit to the club including social events.

I hereby authorize the Club to offset any outstanding indebtedness due for payment if said payment has not been satisfied in the month, which it was due.
