Memberships

Golf:

Golf membership includes full access to the golf course, clubhouse, clubhouse rental discounts, pool, social events, and driving range at no additional cost every day of the week. Golf members also enjoy Acumen Golf's two other golf courses, Brandermill Country Club (limited availability) and Birkdale Golf. Birkdale and Brandermill access is restricted to after 11AM and reservations must be made through the Hanover Pro Shop with a 5-day booking window.

Under 35 Golf Membership

Individual - **\$150** for golf only, **\$245** with unlimited cart use per month

Family - **\$200** for golf only, **\$330** with unlimited cart use per month

Full Golf Membership

Individual - **\$175** for golf only, **\$270** with unlimited cart use per month

Family - **\$225** for golf only, **\$355** with unlimited cart use per month

Off-Peak Golf Membership

Individual - **\$150** for golf only, **\$245** with unlimited cart use per month

Family - **\$200** for golf only, **\$330** with unlimited cart use per month

*Golf is restricted to after 10am on Weekdays and after 12pm on Weekends and Holidays. This category does not include reciprocal access to Birkdale and Brandermill.

Unlimited Use Cart Plan

Cart plan usage is valid at any Acumen Club.

\$95 a month for Individual usage, **\$130** a month for Family, *12-month commitment

GROUP INCENTIVE- If 4 or more golf members all join at the same time, they will be eligible for a \$50 a month unlimited cart plan rate for the first 12 months of membership.

Additional tax of 6% will be added to any cart fee monthly.

Social:

Social membership includes full access to the clubhouse, discounts on rentals, social events, pool, and driving range at no additional cost.

Social Membership Individual - **\$60** a month Family - **\$80** a month *12-month commitment

Pool Only Membership

\$595 per season, charging privileges with credit card on file, and no access to the clubhouse (pool window only). Seasonal cost increases to **\$645** starting on June 1st, 2022. Ask about our swim team.

I understand that I am paying \$0 initiation fee. This includes Summer Pool membership, and I understand that it is a separate entity and not eligible to be downgraded to. There is also a monthly Food & Beverage minimum (\$35 for Golf, \$25 for Social) separate from your fees, anything charged under that amount will be billed monthly. If your bill goes unpaid, at the end of the month a 5% late fee will be applied and will accrue each month until the balance is paid.

I understand that my resignation will not relieve me of outstanding initiation fee payments, purchases, or charges owed to the Club. I understand that my initiation fee is non-refundable and does not grant me any proprietary rights or ownership to Hanover Golf Club, nor does my acceptance as a member and payment of the initiation fee guarantee future membership rights to the Club. I understand that all applications are subject to a routine credit check with the local credit bureau and final approval by the Club. If this application is disapproved by the Club, only my initiation fee will be refunded. I further understand that upon acceptance for membership in Hanover Golf Club, I will abide by the Bylaws of Hanover Golf Club, and all rules and regulations set by the Club. I hereby authorize the Club to offset any outstanding indebtedness due for payment if said payment has not been satisfied in the month, which it was due. I further agree to provide the Club with an updated credit card as requested.
